# Open Letter by the Deans of the Life Sciences Faculties at the Universities of the Republic of Poland

## Your Excellency President, Your Excellency Prime Minister, Your Excellency Minister:

We, the Deans of the Life Sciences Faculties at the Universities of the Republic of Poland, protest against the current and planned for the near future, far-reaching interferences in the valuable ecosystems of our country, in particular the Białowieża Forest and large Polish rivers. We therefore oppose the present policy of exploiting natural resources, carried out without consideration to the social and economic costs of the natural environment degradation. We believe that the current economic activities, including the legal ordinances of the Ministry of Environment, will contribute — through irreversible natural resource devastation — to the impoverishment of our society and an increased risk of natural disasters in our country.

Due to globally increased human impact on the natural environment, setting environmental protection against socio-economic values has become pointless. The belief that "we cannot afford to protect the environment" had turned out to be erroneous and was replaced by the conviction that we cannot afford not to protect it.

Therefore, we require the decision-makers to develop such strategies of managing the Polish natural resources that would replace the purely exploitative attitude and instead combine the protection of valuable natural assets with economic and leisure usage. These new strategies should take into account the socio-economic costs of the excessive exploitation of nature, including the consequence that degraded ecosystems can lose the capacity to deliver services for humans.

In particular, we would expect compliance with the state and international laws and regulations, pursuant to which the natural processes must be preserved in the ecosystems of the Białowieża Forest and large Polish river valleys.

We would also like to express our deepest concern over the current situation in the Białowieża Forest, where mass logging leads to the destruction of the most valuable forest complex in our country. Moreover, we would like to point out that these activities pose a real risk of placing the Białowieża Forest on the UNESCO List of World Heritage in Danger.

We call upon you to start a dialogue with scientists who oppose the ongoing interference in the natural environment, and to take into consideration the current scientific knowledge in making key decisions.

Let us not forget that we have a moral and legal obligation to preserve the natural environment for future generations in at least as good condition as we found it.
